#### Naming a Program List in CADAC

The Program List (PL) naming convention serves the purpose of easily identifying the agency, the application deadline year, the number of organizations, the funding cycle as well as any additional specifications.

This allows CADAC to know which program lists to prioritize during the reconciliation process and to easily identify information about Program Lists.

Please follow this structure when naming a program list:

- Funding Agency acronym;
- The application deadline year;
- The name of the program (including the program number if applicable);
- The number of organizations part of the list (to be confirmed before PL is approved);
- Either "A" for Annual or "MY" for Multiyear;
- Additional specifications (I.e., Forecast, Internal use, Research, etc...).

### Agency acronym-YEAR-Program Name/Number of Orgs-A or MY Examples:

CCA-2022-Theatre-4539-MY MAC-2022-Visual Arts-965-MY-Research TAC-2025-Dance-265-MY-Forecast

N.B. When an Agency Supervisor approves the Program List (PL), they should confirm that the number of organizations in the PL list is accurate before approving.

We request that each funder provides a unique Master List that includes ALL organizations that require reconciliation for said application deadline year including orgs with multi-year and annual funding.

For this Program List, we ask that you use the above convention and add the acronym "ML" at the beginning of the PL name.

#### **Example:**

ML-TestAgency-2024-9-MY

#### **Important**

Please follow this structure within the Program List for:

<u>Application Deadline</u>: Use the last day of your organization's fiscal year

<u>Start Date</u>: Use the first day of your organization's fiscal year

<u>End Date</u>: Use the last day of your organization's fiscal year
